### **Canadian Outlook – Supply and Demand Mismatch**

- Modest growth of the Canadian economy 2%
- Return to 2016 levels of spending about \$2B less than in 2017
- Forecasting a shortage of workforce
  - Competition for STEM graduates
  - Grow pool of qualified applicants by targeting women, New Canadians, indigenous



# **Current Political Climate – Investor Confidence in** Canada?

Prime Minister Justin Trudeau's majority Liberal federal government is in the third year of its mandate.

- Phase II of \$180B infrastructure spending being tied to social benefits
- Marijuana will be legal October 17: no fit to duty standards
- Increased criteria for environmental considerations doubled
- Trade wars of concern
- Increased security clearance requirements for federal projects

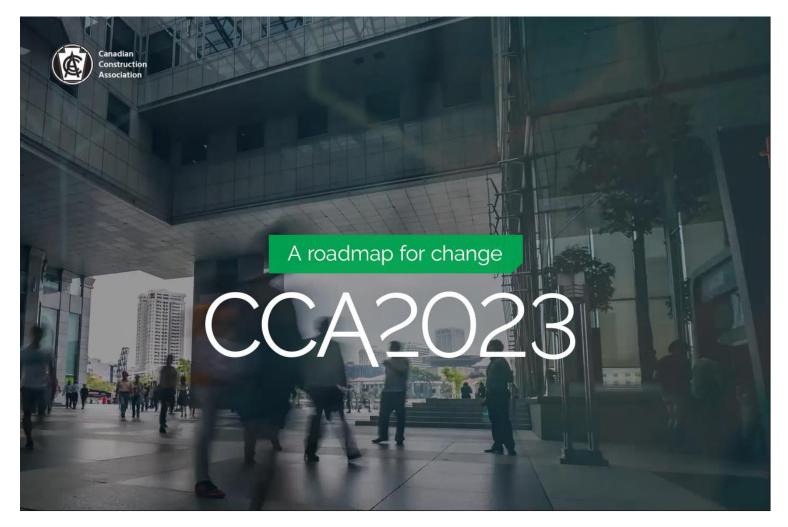


## **Construction Industry Environment**

- Growth of complex projects and industry capacity:
  - Fewer middle sized firms, fewer members, partner revenue models
- Changing customer requirements:
  - Green, lifecycle, social benefits, collaboration
- Construction industry image:
  - Not desired employer, yet talent shortage
- CCA has good, but quiet reputation with government
- Technology adoption is critical, but lagging

#### <u>Trends</u>

- Calls in Canada for reciprocal/retaliatory trade barriers and industry support/market protectionist measures.
- Resurgence of local/regional preferences in public procurement practices building greater internal trade barriers within Canada despite a recent *Canadian Free Trade Agreement*.
- The emergence of "social procurement" in public procurement in Canada





#### **Impact of Tariffs and NAFTA**

• A NAFTA termination has been estimated at a cost to Canada of .4 to .5% of GDP.



- The impact of lower corporate tax rates in the US could be much more devastating on Canada's economy!
- Overall impact of the recent US steel and aluminum tariffs on the Canadian economy will be slight (i.e. 0.2 to 0.3 per cent of GDP) but will be detrimental to Canadian construction industry



#### What is CCA Doing?

- Tariffs Requested relief
  - Accelerated depreciation, R&D fund, protection against rising costs
- Fair competition Successfully lobbied against governmentcontrolled entity purchasing a Canadian construction firm

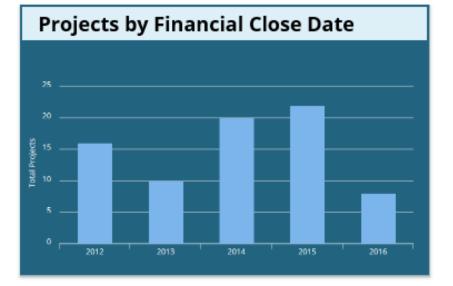




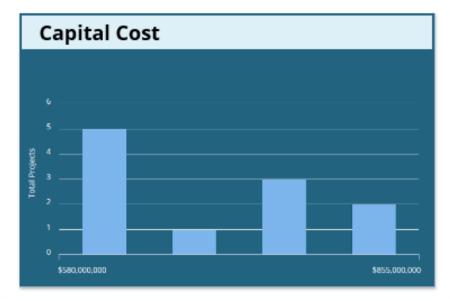

## **Diversity of Construction Workforce in Canada Today**

- Women remain dramatically under-represented in the industry, accounting for only 12% of the total workforce
- One of the top employers in Canada among Indigenous people today.
- Canada's Indigenous population is youthful and growing with a 42.5 per cent increase since 2006, a growth rate more than four times that of their non-Indigenous counterparts
- As many as 277,000 new construction workers will be needed this decade.



# **CCA's Education and Diversity Efforts**

- Gold Seal and The Lean Institute of Canada certification programs
- IBC and Building Smart Canada are national leaders in the use of BIM technology in the Canadian built environment
